# APPLICATION PROCEDURE: INTERNATIONAL FUTBOL X-CHANGE

Complete the entire application and return the original copy to IFX. Applications will not be accepted unless they are complete and all attachments included. Please print legibly in blue or blank ink. Make a copy of the application for your own records, and we recommend using a traceable carrier service such as certified USPS, DHL, or FedEx for shipment.

# We recommend that you keep a folder with copies of all documents related to your exchange program.

# **Required Attachments:**

- \$750 Enrollment deposit: This deposit is put toward your total program cost. It should be made payable to IFX via check or money order. IFX also accepts payment by VISA or MasterCard via our online registration platform. Do not forget to include your name on the payment. Payment made by credit card are subject to a 3% transaction fee and one time \$7 registration fee.

# **Application Tips:**

# Program Prerequisites:

- Ages: 18 and older
- Must demonstrate strong academic record and interest in study of German language (for Language School option) or study of International Business (for University program).
- Participants must be currently competing at a competitive level of soccer in their state or country.
- Participants chosen on a first-come first-serve basis for all of those who fulfill program requirements.

### Visa Requirements:

IFX will provide enrolled Participants with an enrollment confirmation as well as the following items that are usually necessary to apply for a student visa.

- Proof of enrollment in language institute or University
- Proof of accommodation
- Flight itinerary
- Proof of medical insurance

Participants are responsible for meeting all the visa requirements of the relevant country of their program. Requirements may vary depending upon the responsible consulate of your area, so please check with your local consulate for exact visa requirements.

Germany may require participants to deposit funds for living expenses into a locked account in a German bank as a requirement for visa approval. Participants are thus advised that as a requisite for admittance into our program, they must be able to not only meet the IFX financial requirements detailed below, but also those of the German consulates. - LATE PAYMENTS:

# **IFX Terms of Service**

BY USING International Futbol X-Change, LLC, ("IFX") SERVICES YOU ENTER INTO A BINDING CONTRACT AND AGREE TO COMPLY WITH AND BE BOUND BY THE FOLLOWING TERMS OF SERVICE. UPON YOUR USING THE SERVICES, THESE TERMS OF SERVICE IMPOSE OBLIGATIONS ON YOU AND LIMITS ON YOUR USE OF SUCH SERVICES. PLEASE READ THEM CAREFULLY.

**1. Parties.** International Futbol X-Change, LLC, ("IFX") is a California Limited Liability Company, with its place of business at 1110 Burnett Ave. Ste. H, Concord, CA 94520. IFX and "You", as a person utilizing any of the services offered by IFX, including minors (each a "Participant"), who are being represented by their parent(s) or legal guardian(s) using IFX services for the benefit of such minor, are a party to this contract.

**2. Services.** IFX provides to Participants consultant services about international education and soccer Programs all over the world. IFX assists Participants with selecting the most appropriate Program and the registration process. THE PROGRAMS ITSELF ARE NOT OPERATED BY IFX AND IFX HAS NO AUTHORITY OR CONTROL OVER THE PROGRAMS, ITS OPERATIONS OR POLICIES.

**3. Separate International Education & Soccer Program Terms and Conditions**. Each education and soccer Program ("Program") may have separate specific policies ("Program Terms and Conditions"), which you are bound by as a Participant. IFX STRONGLY ADVISES THE PARTICIPANT TO READ AND FULLY UNDERSTAND THE SEPARATE PROGRAM TERMS AND CONDITIONS. While IFX will do its best to provide to the Participant information about the Program Terms and Conditions during the registration process, it is your responsibility as a Participant to be informed about and follow such Program Terms and Conditions. You may contact IFX with any questions about the Program Terms and Conditions prior to applying for a place in a Program.

**4. Payment Terms.** Participant is required to make payments directly to IFX ("Payment"). Payment terms shall follow the IFX Payment and Cancellation Policies set forth in the IFX application document. Other payment terms may apply, if so stated on the IFX website and/or if agreed to in writing by both Parties to this agreement.

**5. Cancellation by Participant and Refund.** Payments made to IFX are only refundable according to the IFX Payment and Cancellation Policies.

**6.** Cancellation by Operator and Refund. According to the respective separate Program Terms and Conditions, operators of Programs may have the right to cancel the Program for any reason, including without limitation if the number of participants signed up for a given Program is deemed by the operator to be insufficient. Alternate session dates, locations or refunds may be offered by the Programs according with their separate Program Terms and Conditions. In such a case, Payment made to IFX is not refundable, unless refunds from the Program due to the Participant are received by IFX, in which case such refunds will be promptly forwarded to Participant.

Operators of Programs reserve the right to terminate, without refund, the right to participate in Programs for Participants, who, in the operator's discretion, behave in a manner disruptive or dangerous to themselves or others, who are in breach of any applicable local laws, or who appear unfit, through drugs, alcohol consumption or otherwise, to attend.

7. Program Term, Extension and Non-Circumvention. This agreement shall remain in effect until Participant's program end date, or in the case of a program extension, this agreement shall remain in full effect until the newly revised program end date. Should a Participant wish to continue their studies or participation in sport with the same institution for an additional program period at any point following their original program period, the Participant is required to enroll through the IFX program. No direct engagement shall be permitted between Participant and IFX partners or their institutional partners including educational institutions and sports clubs.

**8. Insurance.** IFX strongly advises Participant to purchase travel and medical insurance from a broker of Participant's choice in connection with the participation in the soccer Program, specifically covering possible cancellations described in Sections 5. and 6., as well as medical, travel costs and personal property for all travelers. It is not within the scope of services offered by IFX to advise on any insurance related matters, including but not limited to the insurance coverage, its limitations, insurance claims or underwriting decisions.

**9. Proprietary Rights.** IFX and each Program operator retains the right to use any photographs, videotapes, motion picture, or recording taken during a Program or any other record of the event for publicity, advertising or any other legitimate purpose.



10. Representations and Warranties. IFX PROVIDES THE SERVICES "AS IS" AND AT PARTICIPANT'S SOLE RISK AND REJECTS AND EXCLUDES ALL REPRESENTATIONS, WARRANTIES AND LIABILITY FOR LOSSES ARISING OUT OF ITS SERVICES AND WITHOUT LIMITING THE GENERALITY OF THIS DISCLAIMER, IFX EXPRESSLY DISCLAIMS ALL WARRANTIES AND CONDITIONS OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT EXCEPT TO THE EXTENT APPLICABLE LAW DOES NOT ALLOW THE EXCLUSION OF CERTAIN WARRANTIES OR CONDITIONS OR THE LIMITATION OR EXCLUSION OF LIABILITY FOR LOSS OR DAMAGE CAUSED BY NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF IMPLIED TERMS, OR INCIDENTAL OR CONSEQUENTIAL DAMAGES. In addition, if Participant is registering third parties, Participant represents and warrants that Participant has been duly authorized to act as agent on behalf of such parties in performing the registration. Any additional agreements must be made in written form. If any court of law, having the jurisdiction to decide on this matter, rules that any provision of these Terms of Service is invalid, then that provision will be removed without affecting the rest of the terms. The remaining provisions of the Terms will continue to be valid and enforceable. The Terms of Service, and your relationship with IFX under the Terms of Service, shall be governed by the laws of the State of California without regard to its conflict of laws provisions. You and IFX agree to submit to the exclusive jurisdiction of the courts located within the county of Contra Costa, California to resolve any legal matter arising from the Terms of Service.

# German Student Visa Requirement (Germany Program only)

American, Canadian, Australian, and citizens of a few other select countries may travel to Germany for up to 90 days simply with their passport. IFX's partner will help you to apply for your student visa during this 90 day period while in Germany.

A requirement of the German Foreign Office mandates that each applicant must open a specific type of bank account with a German bank (Sperrkonto) and deposit a stipulated amount of funds into the account. For University students, the amount is 861 Euros times either 6 months or 12 months, depending on your intended stay. You may then only withdraw 861 Euros per month once it has been opened. The intension is to force students to manage their money properly while studying in Germany. For language school students the amount is 947 Euros times either 6 months or 12 months, depending on your intended stay.

For year long language school IFX participants, participants must be able to make a deposit of 8523 Euros just prior to their 4<sup>th</sup> month of the program. This sum accounts for the approximate 9 months remaining in the visa term. For University students, 10,332 Euros is the required amount for the locked bank account also needed to be on deposit just prior to their 4<sup>th</sup> month in the program.

These funds will be in your account in your full control and 861 Euros (University students) or 947 Euros (language school students) may be withdrawn each month at your will.

In some cases, the visa appointment may be scheduled in early December or early January. IFX participants may not under any circumstances miss their visa appointment as a result of returning home for the holidays. If this occurs, IFX reserves the right to charge an additional \$1000 for having to reschedule visa appointments.

It must also be understood that IFX reserves the right to contact the German authorities to cancel their visa during the program should the participant exhibit poor attendance to the German language institute or German University. In this case, the participant would be sent home without any program refund.

These financial requirements of the German government are in addition to the IFX program fees, which must be paid according to the program payment schedule.

These requirements outlined above are in addition to all other visa requirements and while intended to provide guidance, actual requirements of the Foreign Office at the time of applying for the visa may vary somewhat based on their discretion and policy. For a complete list of visa requirements, please contact your local German Consulate.
